- Applications to vote by proxy at this election must reach the Electoral Registration Officer at Horsham District Council, Park North, North Street, Horsham RH12 1RL by **5pm on Thursday 21 April 2011**.
- Applications to vote by proxy at this election applied for on grounds of **physical incapacity**, where that physical incapacity occurred after 5pm on Thursday 21 April 2011, must reach the Electoral Registration Officer at Horsham District Council, Park North, North Street, Horsham RH12 1RL by **5pm on Thursday 5 May 2011**.
