Introduction

Wilder Horsham District is a five-year partnership between Sussex Wildlife Trust (SWT) and Horsham District Council (HDC) working to deliver a Nature Recovery Network for Horsham District.

The project officially commenced in September 2020 when project staff came into post and has since been working closely with local communities and landowners to help reverse the decline in species and habitats and enrich the natural environment for all residents and visitors. This report summarises Wilder Horsham District's (WHD) achievements for the financial year dated 1 April 2020 – 31st March 2021.

Project Progress continued Comments on 2020 - 2021

The Impact of COVID-19

2020 was a globally challenging year with the coronavirus pandemic. This impacted the start of the project which was originally intended to begin in April 2020. In fact it started in the autumn, with the Community Support Officer beginning work on 22 September and The Landowner Advisor on 12 October. This meant that 2020-2021 was a truncated year for the project with both staff in post for less than half the financial year. Additionally Sussex was in lockdown for approximately four months of this, from 5th November to 2 December 2020 and from 21 December to 29 March 2021. During this time engagement with partners and community groups was only possible via online meetings and landowner visits were prohibited. Additionally volunteer work parties were impossible so that aspect of the project could not proceed during the winter of 2020-21.

Project Activity

Although it limited some of the activities the timing of the lock-down was not as problematic for project delivery as it might have been at a later time. As this is the first year of the project there was a considerable amount to do in terms of setting up the project infrastructure as well as a significant amount of desk-based work that could still be progressed during lockdown.

In terms of the project infrastructure the: Nature Recovery Award process, financial infrastructure & reporting, social media, webpage, communications strategy, project board reporting & project report cards were all set-up during the first six months of the project. Good communication channels between SWT and HDC have meant that this proceeded smoothly despite the COVID-19 restrictions.

The enforced period of deskwork also allowed the project to make fast progress on producing a draft Nature Recovery Network (NRN) for Horsham District (Figure 1). This is "living document" that uses available data to map how an effective NRN could be built for Horsham District, identifying not only the core areas but areas of high habitat potential that might provide the connectivity that is vital for Nature Recovery. Landowner Engagement Highlights

Landowner engagement was limited by COVID-19 restrictions, but some site visits were possible during the periods of relaxation in October and December. There are many land management techniques that can be used to promote Nature Recovery and the project will aim to utilise as many of them as possible. Regenerative agriculture and rewilding in particular have huge potential as, in different ways, both replicate natural systems. During the early weeks of the project we began working with two rewilding projects in the District.

The Knepp Estate is a long-running rewilding project at the centre of the District, and we have been discussing its crucial role in the Nature Recovery Network for Horsham District.

At the other end of the timeline The Dragon's Estate, to the North of Knepp, is just about to beginning its own rewilding project and we have been both advising them and supporting them in their application to Natural England. The project will increase the area for nature Recovery in the heart of Horsham District and will also add a new element as it is much more wooded in character than Knepp. We look forward to working with them as the project develops.

Organisation Engagement Highlights

Wilder Horsham District gave two talks to Horsham District Council staff in 2020-21 as part of our commitment to provide three days of training for staff and members per annum. We have been delighted with the high engagement and positive feedback we have received after both talks. They were extremely well attended, with 49 and 51 people signing up respectively.

For our first talk, we introduced the Wilder Horsham District project. 95% of the 22 staff who responded said they would like more presentations on the project as it develops and would like to attend the next talk, and 100% rated the talk as 'good' or 'excellent'.

'It was a great and informative session, and I'd just like to thank all of the speakers for their time and knowledge. This is a really exciting project for the District, and I look forward to seeing where it goes from here!'

'Overall excellent presentation and I hope Wilder HD will be an active part in anything that HDC does or is involved with. Volunteer registered mentioned – would be keen to sign up.'

In this feedback, several staff also requested more information on what they could do for wildlife as an individual, and so for our second talk we talked about 'What you can do for wildlife in your garden'. 100% of the 15 staff responses said they had been inspired to change their wildlife gardening habits as a result.

We have been overwhelmed by the response and interest of Horsham District Council staff, which has also included many requests to volunteer for the project. We hope to continue to offer value through our talks in the future and look forward to getting staff involved with project volunteering.

Community Engagement and Media Highlights

The response from local communities and individuals to the project has been overwhelmingly positive. Existing community groups promoting conservation and nature recovery have shown great interest in working with us, as have new communities and individuals who wish to be involved. For a new project, such a level of initial response from a variety of people within Horsham District is very exciting, and we look forward to developing the best ways of supporting such groups and adding value to existing work.

The project's work on promoting wildlifefriendly verges is a particular highlight. While presenting at West Sussex County Council's (WSCC) 'Who Loves a Pollinator' online event, the topic of verges and WSCC's community road verges scheme was raised. Following the event, and several comments on the project's social media requesting we take action for verges. we held an initial meeting with WSCC to discuss verge management and the promotion of community verges. Subsequent posts on social media about the community verges scheme have reached over 10,500 people, with several communities inspired to start their own discussions around working together to identify and place applications for verges in their local areas. This is our greatest media response to date and highlights the level of enthusiasm and time Horsham District residents have for nature recovery if we can link them with the relevant opportunities and support.

Next Steps

With lockdown ending in March we start engaging with landowners in April. There has been considerable interest in the landowner advice service, and we have a backlog of site visits that had to be postponed.

In particular we will be looking to promote natural processes: Natural Flood Management (NFM), natural grazing systems and natural succession as part of our advice to landowners. The next annual report will include metrics showing how much influence we have had in these areas as well as carbon capture.

We will also be working with colleagues in the Sussex Wildlife Trust to engage further with communities and will be defining what we will be asking of them to promote Nature Recovery as well as what we are offering. We will be starting our volunteer programme. We will be looking to recruit both survey volunteers, to record the wildlife we currently have in Horsham District, and habitat management volunteers, for winter work parties that will go out and help make a difference on the ground.

We will continue to promote the Nature Recovery Award and will work with applicants to help them deliver the best project possible.

We will continue to expand our audience and reach on our social media channels to maximise our online community engagement; share the work we are doing and create new connections. With site visits resumed, new content will focus on sharing photos and details of the project's active work, such as site visits.
