

# PUBLIC HEALTH AND LICENSING LOCAL GOVERNMENT (MISCELLANEOUS PROVISIONS) ACT 1982

# STREET TRADING PUBLIC ADVISORY INFORMATION

1.0	Certain streets (including associated verges and laybys) in the Horsham District are
	designated as either CONSENT STREETS or, PROHIBITED STREETS, for the purposes
	of the control of street trading.

- 2.0 Trading can only occur in a street designated as a consent street, if written consent has been given by Horsham District Council.
- 2.1 The following streets have been designated as "consent streets".

## **Horsham Town:**

**Bishopric** 

Carfax

**East Street** 

Middle Street

Market Square

Medwin Walk

North Street

South Street

Springfield Road

West Street

Worthing Road (from the junction with West Street / Bishopric to the junction with Blackhorse Way).

### Main Roads:

- 3.0 Trading is <u>not</u> allowed under any circumstances in a street designated as a prohibited street.
- 3.1 The following streets have been designated as "prohibited streets":

# Main Roads:

The single carriageway length of the A24 road from the boundary between West Sussex and Surrey at Kingsfold to the Warnham roundabout.

## **Unclassified Road:**

Road known as Sandhill Lane (off A24 and A283, close to Washington roundabout) London Road

The Pike and Washington Bostall from its junction with The Street northwards through to London Road in Washington.

#### **Horsham Town:**

# 4.0 <u>Annual Street Trading Consents</u>

Applications for annual street trading consents must be made on the appropriate application form and must be accompanied by the appropriate application fee. Following consultation with Sussex Police, West Sussex County Council and the relevant Neighbourhood / Parish Council, consents are either granted or refused by Councillors on the Licensing Committee. If an application is refused, the application fee is returned.

# 5.0 Occasional Street Trading Consents

The Leisure Services Department of Horsham District Council co-ordinates the issuing of occasional street trading consents through the Public Health and Licensing Department for the Horsham Town Centre Festival held annually at the end of October.

The Horsham Christmas Lights Committee co-ordinates the issuing of occasional street trading consents through the Public Health and Licensing Department in the lead-up to Christmas, for the "late night shopping days" in Horsham Town.

- 6.0 For the purposes of this information "street trading" has the meaning assigned to it by paragraph 1(1) of Schedule 4 to the above Act, and relates to the selling or exposing or offering for sale of any article in a street, though some exemptions do exist, e.g.:
  - i) In certain instances, the selling or exposing or offering for sale of any article in a street where <u>all</u> proceeds are for charity may be classed as a "street collection". The Licensing Section of Horsham District Council's Public Health and Licensing Department, which issues street collection permits, should be contacted to enquire about the need for a street collection permit.
  - ii) Selling of newspapers / periodicals.
