# Pulborough Neighbourhood Plan 2019-2031

The Neighbourhood Planning (General) Regulations 2012 (as amended) - Regulation 16

Further and additional to my comments submitted against the original regulation 16 consultation on the Pulborough Neighbourhood plan, and in light of both the new evidence submitted and alterations made to the plan and accompanying Consultation Statement, I now wish to raise further representations covering 3 aspects of the proposed plan.

- 1) I share the concerns raised by Historic England concerning the archaeological importance of the land constituting policies 2 and 3 in plan. There appears clear evidence of the likely existence of Roman remains on these sites which are of inevitable importance to the heritage of this country and to this specific area. Surely this should be fully investigated before simply concreting over these potentially historically valuable sites with a new housing estate? The responses from Pulborough Parish Council and the Neighbourhood Steering Group on the concerns raised by Historic England are woefully inadequate and I'm afraid continue to display a blasé attitude to this issue, leaving the impression that they wish to push this aspect of the plan through whatever the cost and without any due consideration to ethical aspects such as history, heritage, environmental concerns, damage to wildlife, increase in carbon footprint or sustainability.
- 2) I am pleased to note that within the revised Consultation Statement, an acknowledgment has finally been given that the land constituting policies 2 and 3 is indeed greenfield (page 15 / Issues and Concerns / a) i) "For clarification, the nurseries are considered to be greenfield and the Submission Plan going out for consultation has been amended.").

#### However:

a) Nowhere in the updated Submission Plan that is available for this consultation has this been mentioned and no alterations have taken place to this effect. Policy 1, section 4.10 on page 26 of the Submission Plan continues to read "Most of the land at New Place Farm is intensively used with numerous structures including polytunnels..." — which ostensibly is a thinly veiled attempt to intimate to the reader that this is brownfield land. This simply isn't transparent enough to the facts, and directly contradicts the attestation within the Consultation Statement that the plan has been altered to make clear the greenfield status of this site.

b) More importantly, the admission in the Consultation Statement that the site is greenfield now makes it clear beyond doubt that the Pre-Submission Plan published for the regulation 14 consultation actively misrepresented the facts around the nature of policies 2 and 3 to the Pulborough community for the purposes of that consultation. As a reminder the Pre-Submission Plan (Policy 1, section 4.10 on page 26) clearly stated "Most of the land at New Place Farm is brownfield". A direct contradiction of the facts and also the clarification now contained in the updated Consultation Statement.

Pulborough Parish Council and the Neighbourhood Plan Steering Group will likely argue that this is a minor and inconsequential change but it is actually hugely important to the Pulborough community because:

- i) This site represents by far the majority of the development acreage within the Submission Plan.
- ii) It fundamentally goes against one of the most vocalised (and published within the plan itself) wishes of the Pulborough Community that development is limited to brownfield sites and absolutely should not impinge on greenfield.
- iii) At the most basic level the regulation 14 consultation was conducted on a factually incorrect and actively misleading basis.

As a result in order to have any validity, the regulation 14 Consultation should be run again, this time with the correct facts in place around the nature of the land constituting Policies 2 and 3. I believe it is only fair that the Pulborough Community have the chance to comment with the facts in front of them, and certainly not a statement that the land is brownfield in any sort of perceived attempt to assuage anticipated objections to this aspect of the plan.

Should the plan move forward to independent examination and/or referendum without this corrective re-run of the regulation 14 consultation, then a legal challenge will now almost certainly be pursued either individually or through DLRA Ltd on behalf of all of its residents. The evidence after all is now quite simply there in black and white in the form of the direct contradiction between the Pre-Submission Plan statement and the amended Consultation Statement.

- 3) It should be of interest and pertinence to any independent examiner that there appear to exist discrepancies in some of the plan content and statements around actual ownership of some of the land constituting policies 2 and 3. In our own conversations with the operators of the nursery on this site:
  - i) They do not appear to agree with the statements within some of the plan documentation that the operation is no longer commercially viable, and neither are they under the impression that they have been consulted on this. Which again raises concerns that the plan is proposing to remove one of Pulborough's few employers from operation.
  - ii) Whilst most of the nursery site is leased from the landowner, they are under the impression that certain portions of the site are actually within their own legal ownership and would not be made available for the proposed development. Why therefore would they be included within the Submission Plan when they are not available, particularly when numerous other locations on the Site Assessment Report have been immediately discounted for this very reason? One is therefore left questioning whether the nursery operators have even been approached as part of what anyone would reasonably expect as due diligence within the drafting of the Submission Plan, or whether at face value negotiations have simply been restricted to the

landowner benefitting from the potential sale.
