### SOUTHWATER AND SHIPLEY NEIGHBOURHOOD DEVELOPMENT PLAN AREA DESIGNATION

Southwater Parish Council and Shipley Parish Council have agreed to progress a joint neighbourhood plan. In accordance with the Regulation 5 of Neighbourhood Planning Regulations General 2012 (as amended), Southwater Parish Council together with Shipley Parish Council, have submitted a joint application for the designation of a neighbourhood area comprising the whole of Southwater Parish and the whole of Shipley Parish. This application is made in accordance with Regulation 5 of the Neighbourhood Planning (General) Regulations 2012 (as amended). Regulation 5 requires that an area application submitted to the local planning authority must include:

1. a map which identifies the area to which the area application relates
2. a statement explaining why this area is considered appropriate to be designated as a neighbourhood area; and
3. the organisation or body making the area application is a relevant body for the purposes of section 61G of the 1990 Act.

Horsham District Council is inviting representations from stakeholders to comment on the application for a designation of the neighbourhood plan area comprising both Southwater Parish and Shipley Parish respectively. The consultation will start from **19 June 2026 and conclude at 5pm on the 7 August 2026** for 7 weeks.
