

PUBLIC PATH DIVERSION ORDER
Highways Act 1980

Horsham District Council (Thakeham)
Public Path (No.2487) Diversion Order 2020

This order is made by Horsham District Council ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interests of the owners of the land crossed by the footpath described in paragraph 1 below, it is expedient that the line of the path should be diverted.

Abingworth Homes Limited and Mr & Mrs Binnington of Thakeham Place Farm, The Street Thakeham RH20 3EP have agreed to contribute towards any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public and to defray any compensation which becomes payable in consequence of the coming into force of this Order.

West Sussex County Council have been consulted as required by Section 120(2) of the 1980 Act.

BY THIS ORDER

1. The public right of way over land situate at Abingworth Meadows Storrington Road Thakeham West Sussex in Thakeham Parish and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 28 days from the date of confirmation of this Order.
2. Notwithstanding anything in paragraph 1 of this Order, where immediately before the date on which a highway is stopped up in pursuance of this Order there is apparatus on, under or over that highway belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus they then had.
3. There shall be at the end of 28 days from the date of confirmation of this Order be a public footpath over the land situate at Abingworth Meadows Storrington Road Thakeham West Sussex in Thakeham Parish described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this Order.

SCHEDULE

Part 1

Description of site of existing path or way

180 metres length of Public footpath No 2487 from Point A (OS grid reference 510677 E, 116962 N) to Point B (OS grid reference 510683 E, 116809 N) that currently runs along the north and east side boundary of the cattle field is to be stopped up as indicated on the Plan

Part 2

Description of site of new path or way

140 meters new length of Public footpath to be substituted from Point B (OS grid reference 510683 E, 116809 N) to Point C (OS grid reference 510570 E, 116899 N) as indicated on the Plan and having a width of 3 meters

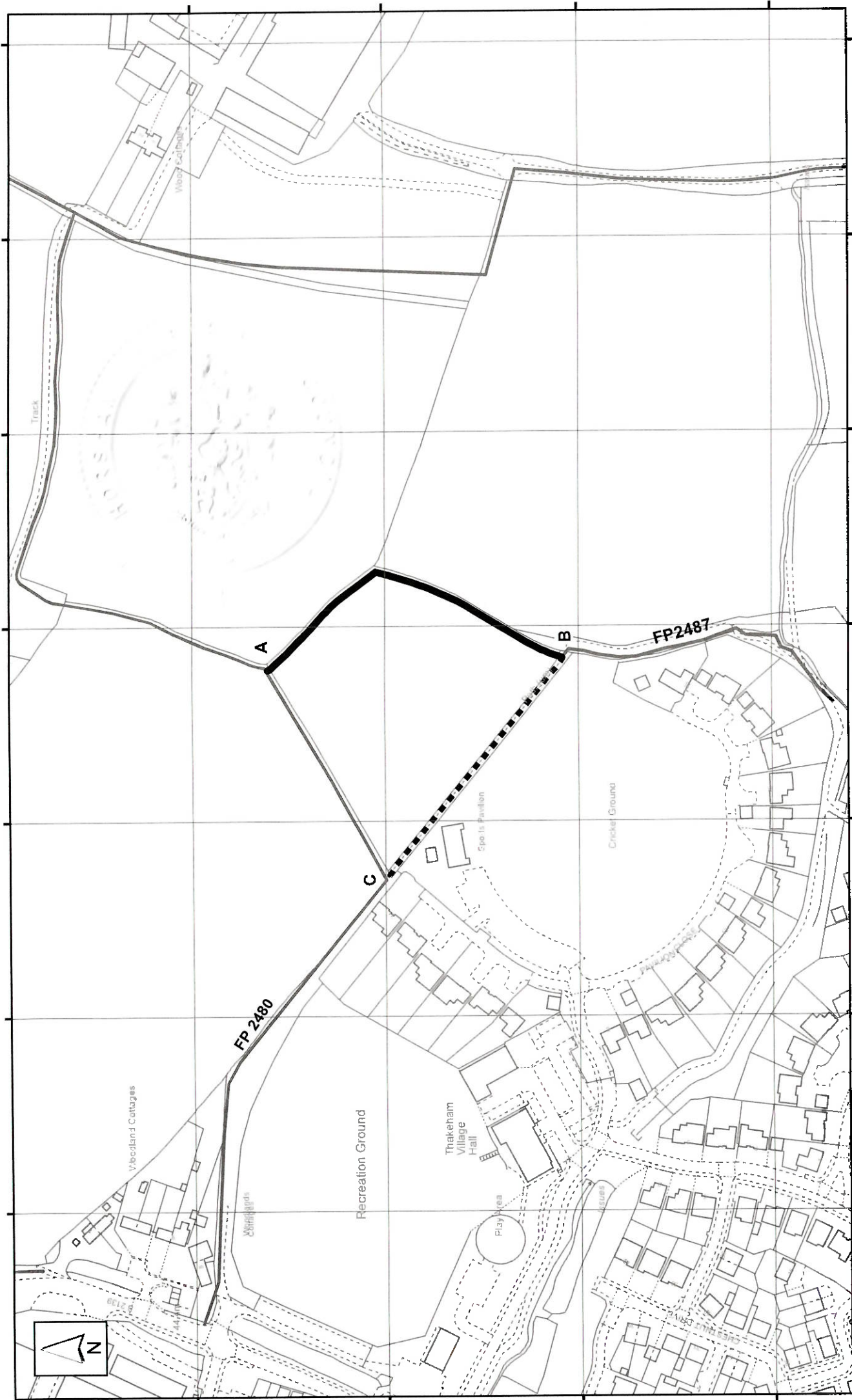
